ADDI-TERMS CONDITIONS

1. The agreement of the **ARTIST** to perform is subject to proven detention by illness, accidents to personnel, equipment or transportation of the **ARTIST**, riots or other civil disobedience, strikes, acts of God, or other conditions beyond their control. In any such event, the deposit will immediately be refunded to the **PURCHASER**, or an equally competent **ARTIST** agreed upon by **PURCHASER** and **ARTIST** at the agent's discretion will be substituted if available.
2. **PURCHASER** and **ARTIST** further agree that this contract is not subject to cancellation (whether or not the engagement is held) unless both parties hereto have agreed to such a cancellation in writing.
3. For the true and faithful performance of every and all covenants and agreements herein mentioned, the **PURCHASER** and **ARTIST** bind themselves each unto the other in the sum of the gross amount set forth above as liquidated damages by the failing party.
4. In the event of a default by the **PURCHASER** in the payment of any sums due to **PURCHASER** under the contract, **PURCHASER** shall pay **ARTIST** all legal fees and other costs incurred by **ARTIST** in the collection of same together and interest on such sums from the engagement date to date of payment in full at the rate of 1.5% per month.
